NOTIFICATION

G.S.R. - in exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Directorate of Plant Protection, Quarantine and Storage, Additional Plant Protection Adviser (Integrated Pest Management) Recruitment Rules, 2010, Additional Plant Protection Adviser (Central Insecticide Board and Registration Committee) Recruitment Rules, 2010, Additional Plant Protection Adviser (Central Insecticide Laboratory) Recruitment Rules, 2010, Additional Plant Protection Adviser (Plant Quarantine) Recruitment Rules, 2012 and Additional Plant Protection Adviser (National Pesticide Reference Repository), Additional Plant Protection Adviser (National Pesticide Investigational Laboratory) Recruitment Rules 2012; except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Additional Plant Protection Advisers in the Directorate of Plant Protection, Quarantine and Storage, Faridabad under the Department of Agriculture and Cpo-operation in the Ministry of Agriculture and Farmers Welfare, namely:-

1. Short title and commencement.- (1) These rules may be called Directorate of Plant Protection Quarantine and Storage, Faridabad Additional Plant Protection Adviser, Recruitment Rules, 2018.

(2) They shall come into force on the date their publication in the Official Gazettee.

2. Number of posts, classification and level in the pay matrix.— The number of said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rule.

3. Method of recruitment, age-limit, other qualifications, etc.- The method of recruitment, to the said posts, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualification.- No person,-

Who has entered into or contracted a marriage with a person having a spouse living; or

Who, having a spouse living, has entered into a contracted a marriage with any person,

Shall be eligible for appointment to the said post:

Provided that the Central government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order for reasons to be recorded in writing, and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.- Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
