Kindly provide me the copy of the tour diary of the Joint Director and other officials who visited alongwith him to Goom, Ahmanpora.</li> <li>7. Was any report prepared by the team that visited Goom, Ahmadpora. Kindly provide us the true clear photocopy of the same.</li> <li>8. Kindly provide me the list of compensation paid to the affected household or land/orchards owners.</li> <li>9. Kindly provide me the list of the damaged property alongwith assessed loss amount and name of the owner of the property such as agriculture land or applu orchards.</li> <li>10. Was any awareness made among the masses to prepare for the future natural disastrous calamities. Kindly provide relevant information.</li> <li>11. How much loss was assess in total in the September 2018 hailstorm in District Baramulla and Budgam.</li> <li>12. How much compensation or relief given to Goom Ahmad pora.</li> <li>13. Was any compensation or relief give to Goom Ahmad pora.</li> <li>14. Why was not nay kind of relief provided to affected land/apple orchard owners of Goom Ahmadpora.</li> </ol>	<p>The 14 points information sought by you does not pertains to Directorate of Extension.</p>
