

The scheme promotes decentralized farmer-friendly extension system in the country. Under the scheme Grants-in-aid is released to the State Governments {In the ratio of 60:40 (Centre:State) to General States, 90:10 for North-Eastern & 3 Himalayan States and 100% for UTs} with an objective to support State Government's efforts to revitalize the extension system and making available the latest agricultural technologies and good




