
2. In order to process the case further, the following information/material is required to be furnished urgently:

Apropos to your letter No.NFSM/Exten-1/U.C (Interim)/125/14 dated 25.06.2014 on the subject noted above, it is to state that the following information/materials may be furnished immediately to facilitate further process for release of funds during 2014-15:-

- (i) As per AUC of 2012-13 the unspent balance of NFSM-Pulses was **Rs.1847.02** lakhs as on 01.04.2013, whereas PUC of 2013-14 shows as opening balance of **Rs.1795.92** lakhs under NFSM-Pulses. Hence, figures of unspent balances under NFSM-Pulses indicated in the AUC of 2012-13 and PUC of 2013-14 do not tally. This may please be reconciled.
- (ii) Audited Utilization Certificate of 2013-14, component-wise, in the form GFR 19-A along with final Monthly Progress Reports (MPRs) of 2013-14, component-wise, be submitted. The Audited Utilization Certificate 2013-14 should be furnished in form GFR 19-A, duly certified by a Chartered Accountant which is a mandatory requirement for release of 2nd /final installment of funds during 2014-15.
- (iii) Latest Quarterly Progress Reports (both physical and financial), component-wise for 2014-15.
- (iv) Details of Accrued Interest Position as on 01.04.2014, Statement of Expenditure component-wise and year-wise from 2007 to 2013-14 duly certified by a Chartered Accountant may please be furnished.
