I am directed to convey the sanction of the President of India for the release of payment of ₹ 1,63,00,000 (Rupees One crore sixty three lakhs only) Grant-in-aid to NOVOD Board for meeting the administrative & establishment cost of the Board under National Mission on Oilseeds and Oilpalm (NMOOP) during 2014-15.

2. The release is subject to terms & conditions laid down in the Administrative Approval issued vide this Department's letter No. 14-1/2014-CA-II dated 25.04.2014 and guidelines issued vide letter No. 1-6/2013- Oil Seeds dated 26th February 2014.
3. The expenditure is adjustable against the funds available under Demand No.1- Department of Agriculture & Cooperation, Major Head - 2401 Crop Husbandry, 114 - Development of Oilseeds, 12-Tree Borne Oilseeds, 120031, Grants-in-aid General for 2014-15
4. The payment sanctioned above is also subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance letter No. 2919/P.11/60 dated the 07th October, 1964.
5. Accounts of NOVOD Board pertaining to Tree Borne Oilseeds under NMOOP shall be open to test check by the Comptroller and Auditor General of India at his discretion and he will have the right to demand the production of books of accounts, vouchers and other papers/documents in this regard.
