Applications of only such officials/candidates will be considered as are routed through proper channel and are accompanied by (i) bio data (in duplicate) as per proforma (**Annexure-II**), (ii) Photocopies of APARs for the last five years attested (signed & stamped) on each page by an officer not below the rank of Under Secretary to the Government of India level, and (iii) **Certificate from the employer that particulars furnished by the official are correct and he/she possesses educational qualifications and experience mentioned in the vacancy Circular/Advertisement, and certificates regarding Vigilance Clearance, Integrity and Major/Minor Penalty, at the end of the bio-data.**



Annexure-I

1. Name of the post: Stenographer, Grade-I, Commission for Agricultural Costs & Prices (CACP)
2. Number of posts: 1 (One).
3. Classification of post: General Central Service, Group 'B', Non-Gazetted, Ministerial
4. Pay Scale: Level-6 (Rs. 35400 to Rs. 112400) in the Pay Matrix
5. Age Limit: The maximum age limit for appointment by deputation shall be not exceeding 56 (fifty six) years, as on the closing date of receipt of applications.
6. Method of Recruitment: By composite method (deputation or promotion).
7. Eligibility: Officers holding Stenographer posts under the Central Government:-
(A) (I) holding analogous posts on regular basis in the parent Cadre or Department;

OR

(II) with 10 years' service in the grade rendered after appointment thereto on a regular basis in Level-4 (Rs. 25500-81100) in the pay matrix or equivalent in the parent cadre or Department.

Note 1:- The Departmental Stenographer Grade-II in Level-4 (Rs. 25500-81100) in the pay matrix with 10 years' regular service in the grade will be considered alongwith outsiders if the departmental candidate is selected for appointment to the post, it shall be treated as having filled by promotion.

Note 2:- The departmental officer in the feeder category who is in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 3:- Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

8. Place of posting:- Commission for Agricultural Costs and Prices, Krishi Bhawan/Shastri Bhawan, New Delhi.

9. Duties and responsibilities attached to the post:
