Brief on India's agricultural trade with UAE

The latest data on agricultural trade between India and UAE is annexed (Tab 1&2).

1) Analysis of agriculture trade between India and UAE

- (a) In the year 2014-15, India's total export of agricultural commodities to UAE was of the order of US \$ 1942.94 million. India's principal exports during this period were boneless meat, meat of sheep, shrimp and prawns, onions, cashew nuts, wheat and muslin, rice, sugar etc.
- (b) During the same period, India's agricultural import from UAE was of the order of US \$ 263.2 million. India's principal imports were dates, colza oil, other food preparation etc.


