Brief on India's agricultural trade with Vietnam

The latest data on agricultural trade between India and Japan is annexed (Tab 1&2).

1) Analysis of agriculture trade between India and Vietnam

- (a) In the year 2014-15, India's total export of agricultural commodities to Vietnam was of the order of US \$ 4385.78 million. India's principal exports during this period were meat, fish, fruits of genus capsicum, cotton, ground nut, cumin etc.
- (b) During the same period, India's agricultural import from Vietnam was of the order of US \$ 315.48 million. India's principal imports were coffee, pepper, preparation used in animal feeding, bamboo, Seeds of anise, badian, caraway etc.


