

Sub.: Sanction for release of payment to National Seeds Corporation (NSC) for the expenditure incurred by NSC (SFCI) on supply of seed minikits of Oilseeds during Rabi 2013-14 (Maharashtra & W.B.) and summer 2014 under NMOOP 2014-15.

Sir,

I am directed to convey the sanction of the President of India for release of the payment of ₹ 1,81,43,350/- (₹ One crore eighty one lakh forty three thousand three hundred fifty only) to NSC (SFCI) for the expenditure incurred on distribution of seed minikits of Oilseeds during Rabi 2013-14 (Maharashtra & W.B.) and summer 2014 under NMOOP 2014-15.

2. The release is subject to terms & conditions laid down in the Administrative Approval issued vide letter No. 14-1/2014-CA-II dated 25.04.2014 and guideline issued vide letter No. 1-6/2013-OS dated 26-02-2014.
3. The expenditure is adjustable against the funds available under Demand No. 1- Department of Agriculture & Cooperation, Major Head- 2401 Crop Husbandry, 114- Development of Oilseeds, 13- National Mission on Oilseeds and Oil Palm, 130031 – Grant- in-aid-General for 2014-15.
4. The payment sanctioned above is also subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance letter No. 2919/P.11/60 dated the 9<sup>th</sup> October, 1964.
5. Accounts of NSC (SFCI) for the expenditure incurred by SFCI on supply of seed minikits of Oilseeds during Rabi 2013-14 (Maharashtra & W.B.) and summer 2014 under NMOOP 2014-15 shall be open to test check by the Comptroller and Audited General of India at his discretion and he will have the right to demand the production of books of accounts, vouchers and other paper /documents in this regard.
